POLICIES GOVERNING TRANSFER OF A HERD IN SPECIAL CASES

- 1. A CHANGE OF HERD OWNERSHIP is allowed at \$5.00 per animal (to a maximum of \$250.00) without transfer applications in any of the following special cases:
 - a) When an owner takes a spouse and/or child or children or children-in-law into partnership to operate one herd as a family enterprise.
 - b) When a whole herd or partial herd (minimum of 15 animals) is transferred at one time by an individual owner or by the owner's estate to a spouse, son, daughter, son-in-law or daughter-in-law.
 - c) When a partial ownership interest in a herd changes hands at one time, as occurs when a partnership dissolves, adds or loses a partners, and when individuals join in a partnership venture.
 - d) When there is a change in ownership name without change in the actual ownership.
 - e) When a *whole herd or partial herd* (*minimum of 15 animals*) *is transferred at one time to one buyer* (without regard to the relationship between buyer and seller).
- 2. PROCEDURE
 - a) Decide on a date on which the ownership change shall be effective.
 - b) Prepare applications in the name of the present owner for all unregistered calves born up to that date (if any).
 - c) Complete the other side of this form in full.
 - d) Submit the completed form with all registration certificates, registry applications and the necessary fees. Transfer Applications Are Not Required.
- 3. A registered HERD PREFIX may be transferred with the herd in any of the special cases listed in Section I above.
- 4. MEMBERSHIPS ARE NOT TRANSFERABLE from one person or partnership to another, nor from an individual to a member of his family, nor from a partnership to one of the partners.
- 5. A free correction of the *membership name* is granted only in the following special cases:
 - (a) To an individual when he takes members of his family into partnership.
 - (b) To an individual, partnership or institution if its name is changed.

NOTE - A COMPLETED APPLICATION FOR MEMBERSHIP is required in all cases when creating a new membership or amending an existing membership.
